Meadowlands Racetrack as 2-year-olds and Freehold Raceway as 3-year-olds

September 26, 2020

Estimated Purses:

Colts:\$40,000

Filly:.....\$40,000

Horses finishing first through fifth who are New Jersey sired shall receive a 2.5% bonus.

Added Money:

Meadowlands will add up to \$11,000 to the 2-year-old pace.

Freehold Raceway will add up to \$11,000 to the 3-year-old pace.

SBOANJ may add up to \$ 5,000 to each age.

Nominations:

\$25 due May 15, 2018. \$150 for yearlings who are not eligible to the SDF program.

Supplementary Nomination:

\$300 by March 15, 2019 for eligible horses not nominated by May 15, 2018

Sustaining Payments (U.S. Funds Only):

On 2-Year-Olds in 2019

March 15, 2019\$200

May 15, 2019\$300

On 3-Year-Olds in 2020

March 15, 2020\$300

All 2 and 3 year-old payments must be made to remain eligible to start. 50% of the May 15, 2019 2 year-old payment will be held for the 3 year-old event in 2020. The purse for each division shall consist of the total of all payments as defined in the payment schedule plus the added money.

Starting Fee:

1% of the purse as published on the condition sheet. Starting fee will not be refunded if horse fails to start. Time of declaration to be determined by prevailing time at track.

Substitutions or Refunds:

There will be no substitutions or refunds if it is later proven that the foal is not eligible to be nominated to this event.

Eligibility:

1. All horses nominated must be by a New Jersey Registered Stallion and so designated by the registrar, the Standardbred Breeders and Owners Association of New Jersey.

2. OR must be eligible to the New Jersey Sire Stakes Standard Development Fund program as determined by the New Jersey Sire Stakes.

3. OR must have foaled in New Jersey. A copy of the USTA foal registration required with nomination form.

4. Each owner of the horse entered to race must be a current member of the SBOANJ.

Racing Conditions:

Each division will be raced in one (1) heat. Racing of this event with regard to eliminations/divisions will be determined by the host track. HORSES MUST MEET TRACK QUALIFYING STANDARDS. All starters are subject to the detention policy of the race-track.

Entries for the Home Grown Pace will be taken at the office of the Race Secretary at the participating track determined by the condition sheet of the track.

All races will be at one (1) mile and post positions will be drawn by lot.

Races at Freehold Raceway will be limited to 8 starters.

Purse Distribution:

5 or more starters: 50% 25% 12% 8% 5%

4 starters: 55% 25% 12% 8%

3 starters: 60% 30% 10%

2 starters: 65% 35%

1 starter: 100%

Rules:

Colts: \$40,000

Filly:..... \$40,000

Horses finishing first through fifth who are New Jersey sired shall receive a 2.5% bonus.

Added Money:

1. Meadowlands Racetrack will add up to \$11,000 to the 2-year-old pace.

2. Freehold Raceway may add up to \$11,000 to the 3-year-old pace.

3. SBOANJ may add up to \$ 5,000 to each age.

Pacing foals of 2019 that are: New Jersey Sired OR not New Jersey sired but New Jersey Sire Stake Standardbred Development Fund Eligible OR not New Jersey sired, not New Jersey Sire Stakes Standardbred Development Fund eligible but foaled in New Jersey.

To Be Raced As:

- 2-Year-Old Pacers in 2021
- 3-Year-Old Pacers in 2022

Host Tracks:

Meadowlands Racetrack as 2-year-olds and Freehold Raceway as 3-year-olds.

Dates:

Definite dates will be published in the USTA Stakes Guide in the year of the race.

Estimated Purses:

\$40,000. Horses finishing first through fifth who are New Jersey sired shall receive a 25% bonus.

Added Money:

1. Meadowlands Racetrack will add up to \$11,000 to the 2-year-old pace colt/gelding division.
2. Meadowlands Racetrack will add up to \$11,000 to the 2-year-old pace filly division.
3. Freehold Raceway will add up to \$11,000 to the 3-year-old pace colt/gelding division.
4. Freehold Raceway will add up to \$11,000 to the 3-year-old pace filly division.
5. SBOANJ may add up to \$ 5,000 to each age.

Nominations:

For New Jersey Sired and Standardbred Development Fund eligible.

May 15, 2020\$25

For yearlings who are not New Jersey sired or not eligible to the Standardbred Development Fund program but foaled in New Jersey.

May 15, 2020\$150

Supplemental Yearling Nominations:

A "second chance" yearling nomination fee can be made in August for those who missed the May payment

For New Jersey Sired and Standardbred Development Fund eligible.

August 15, 2020\$125

For yearlings who are not New Jersey sired or not eligible to the Standardbred Development Fund program but foaled in New Jersey.

August 15, 2020 \$300

Supplemental Nomination:

For eligible horses not nominated by August 15, 2020. This will be made in addition to the sustaining payment.

March 15, 2021 \$300

Sustaining Payments (U.S. funds only):

On 2-Year-Olds in 2021

March 15, 2021 \$200

May 15, 2021..... \$300

On 3-Year-Olds in 2022

March 15, 2022..... \$300

All 2- and 3-year-old payments must be made to remain eligible to start. 50% of the May 15, 2021 2-year-old payment will be held for the 3-year-old event in 2022. The purse for each division shall consist of the total of all payments as defined in the payment schedule plus the added money.

Supplemental Payment (3-year-olds):

For nominated horses who did not make subsequent payments. This will be made in addition to the sustaining payment.

March 15, 2022..... \$1,500

Starting Fee:

Starting fee for all SBOANJ sponsored races will be 1% of the purse as published on the condition sheet. Starting fee will not be refunded if horse fails to start. Time of declaration to be determined by prevailing time at track.

Substitutions or Refunds:

There will be no substitutions or refunds if it is later proven that the foal is not eligible to be nominated to this event.

Eligibility:

1. All horses nominated must be by a New Jersey Registered Stallion and so designated by the registrar, the Standardbred Breeders and Owners Association of New Jersey.

OR must be eligible to the New Jersey Sire Stakes Standardbred Development Fund program as determined by the New Jersey Sire Stakes.

OR must have foaled in New Jersey. A copy of the USTA foal registration required with nomination form.

2. All owners of horses drawn in to race in the eliminations and finals of any SBOANJ sponsored race must be current members of the SBOANJ

Racing Conditions:

One (1) dash distance of one (1) mile. Race will be split by gender. Post positions drawn by lot. Racing of this event with regard to eliminations/divisions will be determined by the host track. HORSES MUST MEET TRACK QUALIFYING STANDARDS. All starters are subject to the detention policy of the racetrack.

Entries for the Home Grown Pace will be taken at the office of the Race Secretary at the participating track determined by the condition sheet of the track.

Races at Freehold Raceway will be limited to 8 starters.

Races at The Meadowlands will be limited to 10 starters.
